APPLICANT UNDERSTANDS THAT AFTER APPROVAL OF APPLICATION, IF APPLICANT FAILS OR REFUSED TO PAY THE BALANCE OF THE FIRST MONTH'S RENT AND/OR THE BALANCE OF ALL DEPOSITS, WHEN REQUESTED BY THE LANDLORD OR HIS AGENT, OR FAILS TO EXECUTE MANAGEMENT'S USUAL RENTAL AGREEMENT, OR REFUSES TO OCCUPY THE PREMISES ON THE AGREED UPON DATE, APPLICANT'S DEPOSIT WILL BE RETAINED TO COVER ANY EXPENSES OR RENT LOSS DUE TO HIS CANCELLATION.
3. LANDLORD AND AGENT WILL NOT BE BOUND BY ANY REPRESENTATIONS AGREEMENTS OR PROMISES MADE BY LANDLORD OR AGENTS UNLESS CONTAINED IN THE WRITTEN LEASE OR RENTAL AGREEMENT SIGNED BY LANDLORD OR HIS AGENT.
